CONNECTIVITY AND EQUIPMENT AGREEMENT FORM

It is the responsibility of the parent/guardian to obtain internet service in the household. ACEA will not provide wireless routers or internet equipment.

Equipment is being provided to you for your child's academic support. This is a tool intended for use at home in their classes for their academic achievement. This equipment is intended to be used responsibly. To that end, by signing and accepting to use this equipment, you agree to the following, understanding that parent/guardian rules and expectations also apply:

- 1. I agree to use this equipment responsibly and in keeping with the District's code of conduct, board policies and acceptable use policy.
- 2. I understand this equipment is solely intended for my child's use and not for use by others (including friends and family). Therefore, I am solely responsible for what happens on or with this computer.
- 3. I understand that I am fully responsible for the care and maintenance of this equipment. Care is defined as returning equipment free of physical damage. Maintenance is defined as observing proper operating procedures, supervising the equipment and assuming full financial responsibility for the equipment while it is in my possession.
- 4. I understand that all repairs to this equipment must be made by district technology staff or agents authorized by the District.
- 5. I agree to not disable or impair computer virus scanning software or other protective devices installed on this equipment.
- 6. I will report to the school's technology support staff any problems or changes in function that adversely affect the operation of the equipment.
- 7. I will not store or access any illegal or inappropriate content on this computer in any form.
- 8. I understand it is my responsibility to return the equipment in the same condition it was received (considering natural aging and normal use).
- 9. I agree that loss, theft or damage of the equipment will be immediately reported to local authorities and ACEA and will be my responsibility to rectify (financially and/or physically as determined by the School). Legal documentation must be returned for auditing purposes.
- 10. I agree that it is my responsibility to return this equipment immediately either when requested or when I graduate or leave the District (unless otherwise indicated), and the District has the full right to inspect or maintain this system as they deem fit.
- 11. I understand the District is not responsible for data stored or accessed on this device, including any financial responsibilities associated for online services or protected content accessed or contracted by the student.
- 12. I understand that I may submit internet bills for the period of time my child is enrolled in ACEA for reimbursement. Families will be given a one-time \$75 Broadband installation allowance and \$35 monthly service allowance for Broadband connection. (Payments do not begin until proof of Broadband service is provided to ACEA). Reimbursements are paid quarterly and due dates for submission are posted on the school calendar.
